This Addendum No. 1 includes clarifications and modifications to the above-referenced bid package. Changes reflected herein shall supersede all previous bid package documentation.

A. PRE-BID MEETING DESCRIPTION OF PROJECT

The proposed work for this project includes the removal of the existing twin pipes and headwalls on Industrial Avenue and replacement with a three-sided concrete box culvert. Work also includes installation of water main hangers. Installation of wingwalls, full-depth reconstruction of Industrial Avenue, and other work as identified on the plans and detailed herein. The scope includes but is not limited to the following:

- a. Installation of Detour and roadway closure, and maintenance during length of construction. Note contractor to maintain driveway access of minimum 15'.
- b. Installation of Sedimentation & Erosion Controls
- c. Installation of temporary water handling cofferdams
- d. Installation of bridge and wingwall footings, channel features, and channel grading
- e. Installation of culvert and remaining channel features
- f. Installation of roadway drainage, water main hangers, concrete parapets.
- g. Full-depth roadway, driveways, railings, plantings, grading, and turf establishment
- h. Removal of all temporary features
- i. Restore Site

B. CLARIFICATIONS

- Materials testing and laboratory cost shall be incurred by the contractor per Item 1 "Mobilization and Demobilization".
- The specifications call for Construction Field Office, this is not a requirement for the Town of Cheshire the contractor may leave the Item 3 "Construction Field Office" blank on Schedule of Items.
- The contractor has 90 calendar days from start of construction to complete the contract work, including opening the roadway. Liquidated damages are \$1000 per calendar day.
